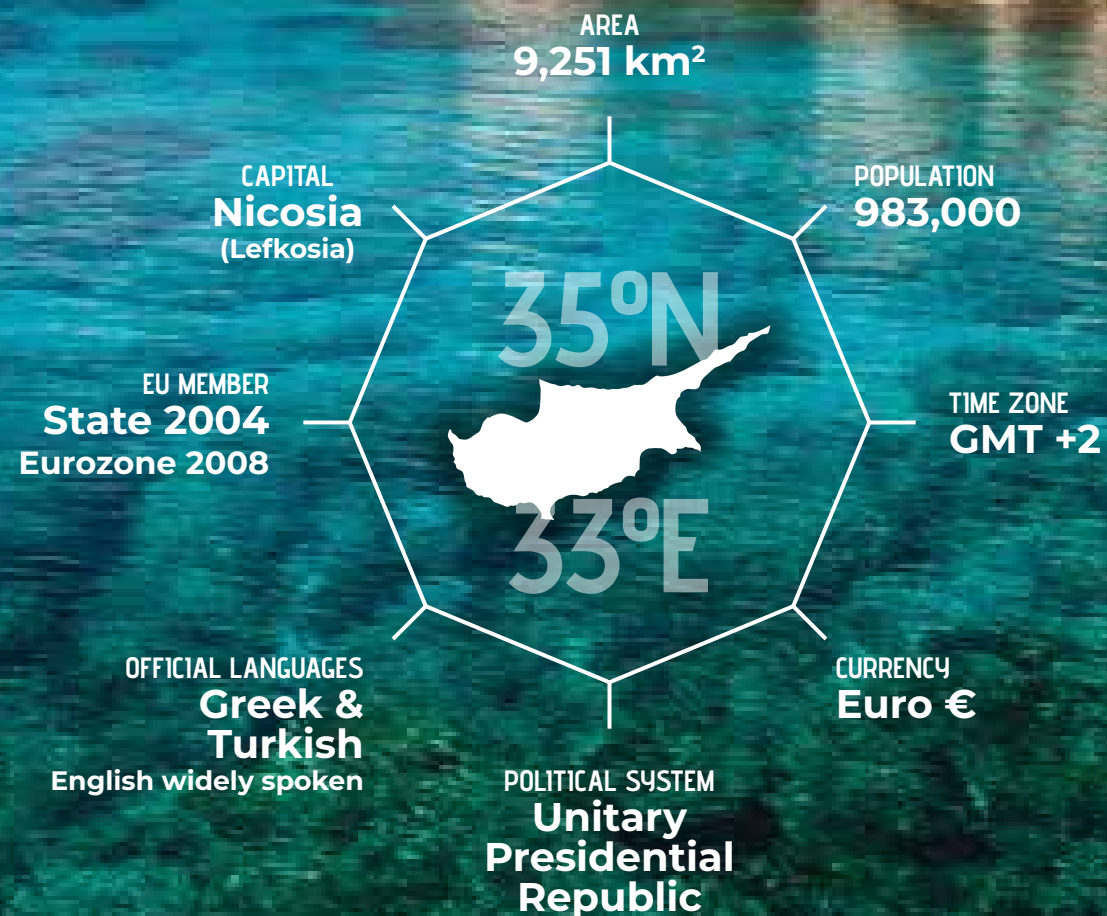
## COUNTRY OVERVIEW

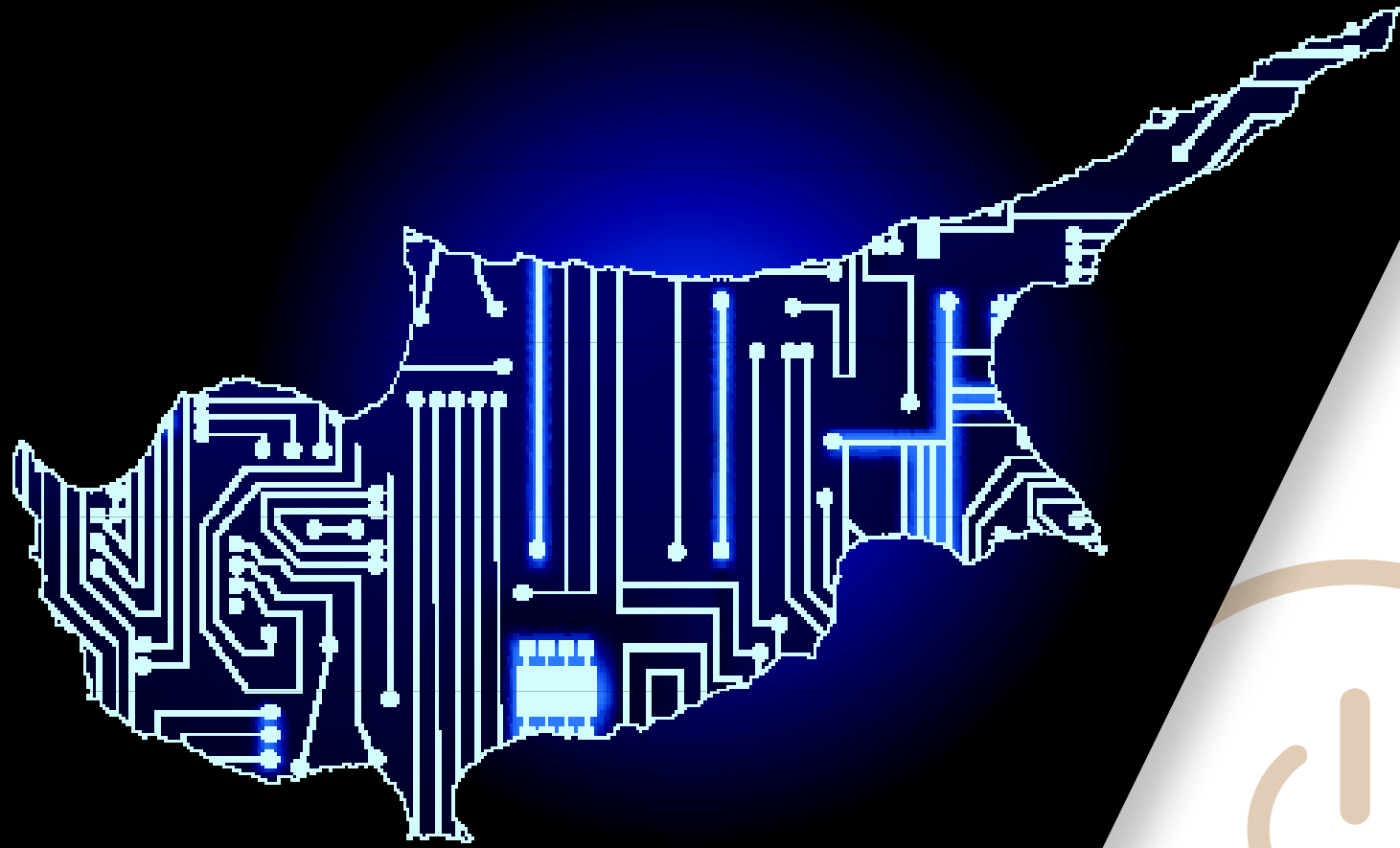

# ICT/Tech, Entrepreneurship & Innovation

Applied research is encouraged through EU or national funding and an attractive Intellectual Property (IP) box regime, while universities and research centres are established in all major cities boosting cutting-edge innovation. Many successful tech companies have already either relocated or expanded their operations in Cyprus, using the country as a base and gateway to and from the EU.

# Energy

The discovery of hydrocarbons in Cyprus' Exclusive Economic Zone (EEZ) created exciting new prospects for the island to become an energy hub in the Eastern Mediterranean. These developments have attracted worldwide interest and significant investment from leading energy giants as well as renowned international providers operating in the oil and gas auxiliary services sector. Cyprus is also developing into a key regional fuel hub, operating a sophisticated oil storage terminal in Vasilikos, the first terminal of its kind in the Eastern Mediterranean, connecting Europe and the Black Sea with markets in the Middle East and Asia. The island has a strong focus on also developing its renewable energy infrastructure and investing in new solutions to harness its potential and improve its energy mix.

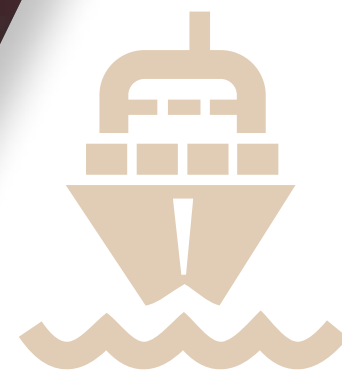

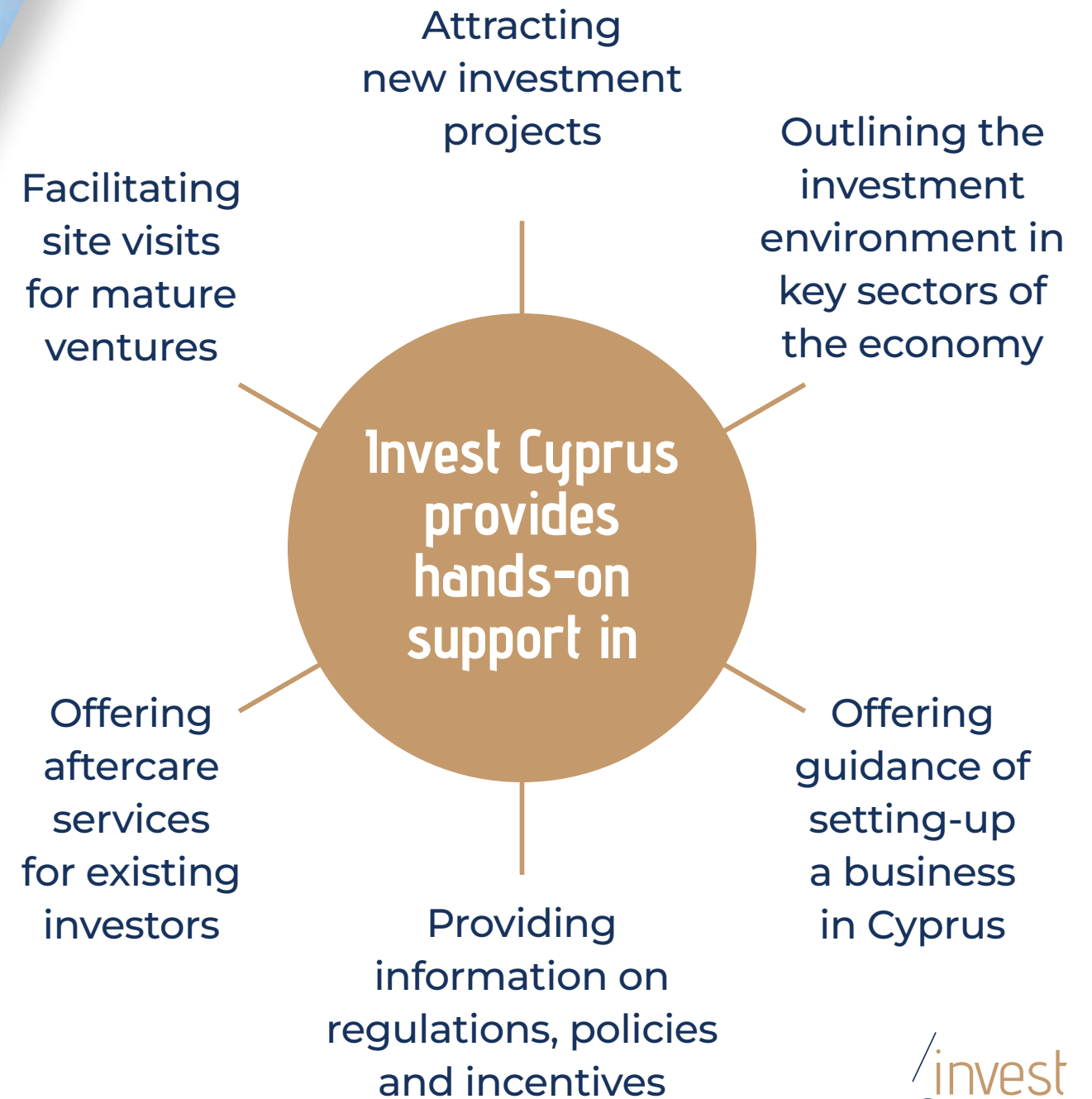
# Film Production

Cyprus is a natural filming studio. The island's deep blue seas and sandy beaches, captivating forests and snow-capped mountains, diverse cultural sites and enchanting locations create a unique environment for filming feature films, tv series and documentaries. In addition to its predictable weather with over 300 days of sunshine a year, the country has modern infrastructure, short distances and good connectivity. Cyprus also offers important incentives encouraging film production. For example, production companies that opt to film in Cyprus can choose between a cash rebate or tax credit and can also benefit from tax discounts on investments made on equipment and infrastructure, and VAT returns on expenditure.
